



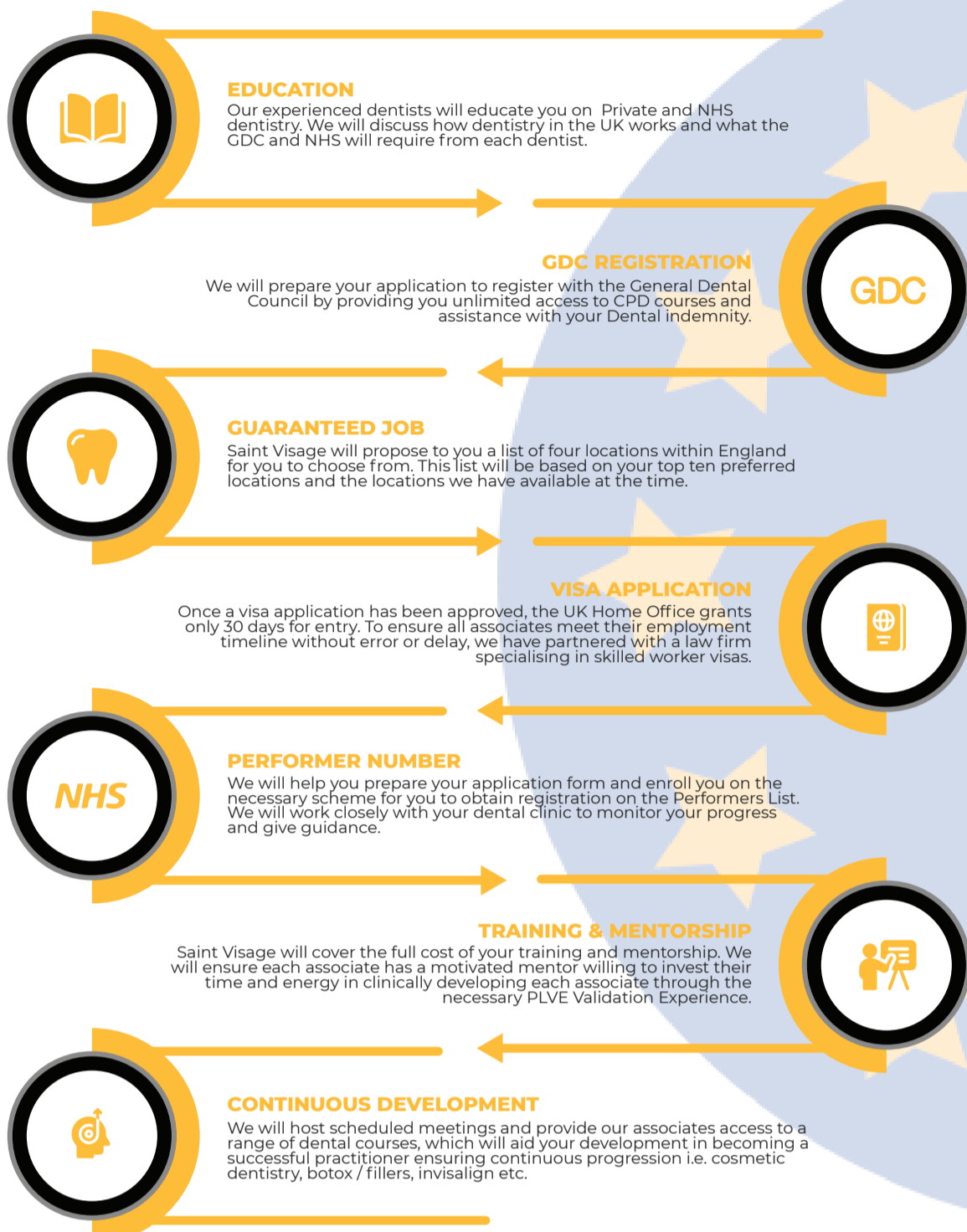
Saint Visage Development Programme
